Mr J Learning for Professionals



Safeguarding Adults Review

Mr J died in 2023 from a perforated bowel. He lived in a South Gloucestershire Care home for many years, his family describe him as settled there. Mr J had a moderate learning disability, Parkinson's Disease, cerebral palsy and other physical medical conditions. Prior to his death he had recurrent and persistent episodes of constipation. In April 2025 a learning event was held and this briefing outlines the key learning identified as part of this review.

Key messages for professionals

Good practice identified



Relationship There was consistent care for Mr J over many years



Emergency Care Paramedic practice was excellent and identified medical risk quickly



Annual Review Mr J's annual review in covid lockdown was

robust



What were the worries?

Record Keeping

Lack of consistency, not always accurate or timely.



Constipation Known link with LD and constipation. NICE guidance not followed correctly



Curiosity 'normal for Mr J' in recording - lack of curiosity about wellbeing



Hydration Not enough focus on Mr J eating and drinking and awareness of dehydration

- Mr J couldn't swallow the antibiotics that were prescribed for him, the prescription was changed to liquid antibiotics, but these weren't available and he never received any antibiotics.
- Records for Mr J are not accurate enough. For example there is a record to indicate a medication has been increased but not the new dosage.
- Inconsistencies in records show a professional recording 'not constipated' when Mr J had only had 3 bowel movements in a month.
- NICE Guidance indicates that medical intervention should be prompt when there is suspected hernia and constipation, Mr J had a new lump suspected to be a hernia alongside symptoms of constipation, blood in poo, and vomiting.
- Constipation was recorded as 'normal for Mr J' there is a risk that when an adult is known really well, conditions can be accepted when further action could be taken to help the adult. Risk assessment should be used and best practice guidance should be followed.
- Mr J had not eaten anything for 3 days and not had bowels open for 9 days when paramedics saw him, but there is no recording about this in other records.
