MESSAGE FROM OUR INDEPENDENT CHAIR

Welcome to the new look, innovative, visually impactive, interactive, informative, 2022 annual report for the South Gloucestershire Safeguarding Adults Board – SGSAB. Thank you, Sarah!

For readers who may not be familiar with some of the language used in adult social services, a "Safeguarding Concern" is a report where there is" reasonable cause to suspect that an adult who has care and support needs, is at risk of or experiencing abuse and neglect".

A Safeguarding "enquiry" is a statutory responsibility placed on a Local Authority where "it believes an adult is experiencing, or is at risk of, abuse or neglect. When an allegation about abuse or neglect has been made, an enquiry is undertaken to find out what, if anything, has happened"

An enquiry follows a concern.

Page 5 of this report reflects the huge volume of work, originating as concerns, some of which then progress to an enquiry, which the Adult Social Care Teams and all our SAB partners have dealt within the timescale of this report – a time, throughout which there were the additional challenges of working during, and dealing with, a global pandemic. Pressures on services have been immense but, despite these, the delivery of safeguarding services to vulnerable adults in our communities, has continued. As you will see within the Quality Assurance sub-group update and, in 1 case within the Safeguarding Adults Review sub-group update, self-neglect features all too often. There is evidence that Covid-19 has caused the number of self-neglect cases to rise. "Why?" has not, so far as I am aware, been researched yet, but I suspect, lockdowns, isolation, reduced contact with family, friends and or carers, have all played a significant part in the reasons for this rise.

Safeguarding Adult Reviews – SARs, are a vital part of learning and improving safeguarding practices the object being to learn where partnership working could be improved to prevent, or at least reduce, the risk of similar occurrences but these too have added further pressure on all SAB partners involved. The fact that we commissioned two, "discretionary" SAR's evidences the importance we place on learning. Where relevant, that learning is them threaded into the numerous and varied training courses offered to all our partners.

Finally, I would like to thank all members of the Board and in particular, the sub-group members, for their commitment to the work of the Board as set out in our business plan.

ABOUT THE BOARD

Safeguarding Adults Board have three main duties

- Develop and publish a strategic plan setting out how they will meet their objectives and how their member and partner agencies will contribute
- Publish an annual report detailing how effective their work has been
- Commission safeguarding adults reviews (SARs) for any cases which meet the criteria for these.

The board has an independent chair, Tony Oliver. The board structure consists of quarterly full board meetings, quarterly meeting of a performance monitoring and subgroup chairs group and five permanent subgroups, for this reporting period, all of these meetings have taken place virtually. This has worked well, and attendance has remained good. The subgroups are:

SAFEGUARDING ADULTS REVIEWS



During the year 2021-22 the SAR sub group

received our highest number of referrals in a year.

Six cases were referred for review by the SAR sub group.

Three of these did not meet the criterial for a SAR.

One met the crietria for a SAR and this has commenced and is due to be completed by September 2022

Two met the criteria for Discretionary SARs under the Care Act 44.4 and we pioneered a new, swifter approach for these two SARs. This approach is now being used by other Safeguarding Adults Boards. You can read the Discretionary SAR Learning below:






LEARNING AND DEVELOPMENT

The SAB offers a comprehensive multi agency safeguarding training offer, although much of this continues to be delivered online. Overall attendance rate is 82%



A brand new course has been added this year - Adult Exploitation



225 delegates attended 'Raising Safeguarding Concerns'

100% of people said they felt good or very good in terms of their confidence after this course People said they knew what to do if they have concerns about an adult

Delegates on all training are sent a follow up evaluation six weeks after the event to try and gather some impact evaluation data so that changes in practice can be identified.

13 Provider organisations are part of the Trained Trainer network delivering the Raising Safeguarding Concerns course to their own staff.
