Loan Sharks

A brand new 'Stop Loan Sharks' reporting app was launched on Wednesday, September 23, and you can download for free on the App Store and Google Play.

The app is mainly aimed at frontline professionals and provides useful information on how to recognise the signs of illegal money lending, respond to disclosures and where to refer clients to for specialist support.

Working with Respect accredited organisations (Splitz, Barnardo's & Phoenix DAS) the 6-month abuse reduction programme is being offered as part of a research study.

We are **open to referrals from** Bristol, North Somerset, South Gloucestershire, Somerset, Wiltshire, Blaenau Gwent (South Wales).

Who is suitable?

- Men who are or have been using violence/abuse in their relationships with women partner(s) or ex-partners
- Men who are concerned about their behaviour
- Men aged 21+
- Men who can understand English well enough to take part in a group programme
