Learning Brief: Adult B

Adult B died in November 2019. In March 2020 a meeting was held to determine whether her death met the criteria of a Domestic Homicide Review (DHR). While it did not meet the criteria a learning review was undertaken.

This briefing summarises learning identified. Police data showed a long history of domestic abuse towards Adult B from her family, mainly from her son. There is also a history in the police reports of alcohol misuse by Adult B and family members.
