CAPO Children Affected by Parental Offending

Children and young people affected by parental offending (CAPO) are often described as a "hidden" or "invisible" group because they are not systematically recorded in England and there is no statutory response to their needs. Children of prisoners are twice as likely as their peers to suffer poor mental health and 3 times as likely to be involved in anti-social behaviour (SCIE, 2008). CAPO often experience the negative effects of stigma, social isolation and fractured relationships within their family and community.

Stop Adult Abuse Week is a combined campaign across the region including the Safeguarding Adults Boards in South Gloucestershire, Bristol, Somerset, B&NES and North Somerset.

Publication of a Safeguarding Adults Review (SAR)



The Safeguarding Adults Board have published a SAR following the death of 'Mr.D' a man in his late 50s who died by suicide in 2021. Mr D had a diagnosis of Paranoid Schizophrenia and Depression. He also struggled with back pain, although he lived in South Gloucestershire, he was keen to return to Swindon where his family live. There was evidence of self-neglect but these factors were not recognised by those working with him at the time.

National Centre for Domestic Abuse (NCDV)



The NCDV are providing two sessions for practitioners from all agencies. This will cover the Legal Definition of Domestic Abuse; how funding is considered - reviewing the option of Legal Aid and other support for Victims/Survivors. The session includes information about the benefits of the civil orders available to victims, explaining each order - Non Molestation, Occupation and Prohibited Steps Orders, in addition to DVPN/DVPOs. Undertaking Safeguarding Enquiries

This course is for senior members of staff in care provider agencies who work in partnership with South Gloucestershire Council and have a lead responsibility for safeguarding.

- understand the South Gloucestershire process roles and responsibilities (S42 Care Act 2014)

- understand the **importance of independent advocacy** and when to use it.

September was FASD Awareness Month



Fetal Alcohol Spectrum Disorder (FASD) results when prenatal alcohol exposure affects the developing brain and body.

FASD it is a spectrum. Each person with FASD is affected differently. While more than 400 conditions can cooccur, FASD is at its core a lifelong neurodevelopmental condition. Most of the time, the only symptom of FASDs are behavioural changes, but we wanted to raise your awareness of this disorder as FASD is often not a visible disability. FASD affects more people than autism and is sadly most often undiagnosed or misdiagnosed.
