Life Skills Prevention Centre - Survey

As a professional working with young children and/or families, can you spare 5 minutes to help reduce the number of accidental injuries occurring to young children?



Did you know that accidents are a leading cause of death and serious injury for children? In 2018/2019 across the former Avon area, 36,000 children under the age of four attended hospital because of an accidental injury, most of which occurred in the home.

Lifeskills is a Bristol based charity that has been providing safety education for over 20 years. As a professional working with families and young children, we'd value your input on an exciting new early years project. By completing a short online survey, you can help us understand what more we can do to protect young children from accidental injuries in the future.

This will only take about 5 minutes and all responses are completely anonymous. Even if you have never received safety education training, or feel it is not relevant to your role, your response is important and will help us build a complete picture of what is happening in the area.

It is important that children learn by playing and exploring, but for some, the injuries gained from accidents at home, are severe. Thankfully, most of these accidents are entirely preventable. We believe that it is always better to offer proactive solutions rather than dealing with the consequences of an accident. Your feedback will help determine how injury prevention in the area can be improved and allow us to tailor services to local needs.

Multi Agency Quality Assurance Audits

The Big Ask Survey will run from 19 April to 19 May 2021. 'The Childhood Commission' will identify the barriers preventing children from reaching their full potential, propose policy and services solutions and develop targets by which improvements can be monitored. The Children's Commissioner is asking children how the pandemic changed their lives for better or worse, what their aspirations are and the barriers to reaching them, how things are at home, how their communities and local environment



could be improved, and how they feel about the future and the challenges facing the world.

Spotlight on Policies

When you are working with an adult and you are worried about Self Neglect or Hoarding what tools do you use?

Did vou know we have Multi Agency Self-Neglect Guidance available?

Private Fostering

What is Private Fostering?

Private fostering is when a child under the age of 16 (under 18 if disabled) is cared for by someone who is not their parent or a 'close relative'. This is a private arrangement made between a parent and a carer, for 28 days or more.

Who is a 'close relative'?

Close relatives are defined as step-parents, grandparents, brothers, sisters, uncles or aunts
