

The adults reviewed for this multi agency audit are aged between 20 and 81. Because of the theme all of the adults are female. Some of the domestic abuse was from a partner and some from adult children and one from a parent.

The audit of 16<sup>th</sup> November 2022 reviewed the records of six adults who were identified through Adult Safeguarding under the theme of Violence Against Women and Girls. The aim of the audit was to ascertain whether there were good multi-agency standards for managing cases and whether organisations have implemented a robust and consistent response in line with statutory and good practice guidance, SGSAB policies and procedures and the six key principles underpinning all adult safeguarding work.

The adults in the audit have a range of issues in addition to the Domestic Abuse they were experiencing including Dementia, end of life care, alcohol and substance misuse, mental health, debt, physical disability and pregnancy

## What we are worried about?

The audit group saw concerns in terms of:

- Difficulty in engaging with someone who refuses
- Earlier referral in 2018, this information wasn't initially triangulated with the recent referral
- Housing noted a lack of multi agency work with one of the adults, and there was no use of the escalation policy. Sirona also not aware of the safeguarding information. No evidence of advocacy considered for this adult.
- Initial delay in referral, but good work subsequently.

- Student Social Worker showed curiosity
- Joint visit with GP and Social Worker and joint visit with Housing and Social Worker
- Strong multi-disciplinary approach for most adults including outstanding work with very complex situations
- Referral to Creative Solutions Board
- Use of safety planning
- Involvement of wider family
- Social Prescribing by GP
- Use of MARAC and DRIVE
- Person centred work evident
- Joint work with children's services
- Trauma informed practice evident
