Avon Fire & Rescue



Avon Fire and Rescue Service offer advice and guidance on how to reduce the risk of fire within the home. Through our



targeted prevention work we provide further support to the most vulnerable members of our community, i.e. those who may be more at risk of having a fire in their home and therefore need us most. In these cases we may carry out a free Home Fire Safety Visit.

This is a free pre-arranged visit to the home to carry out a fire safety assessment and provide advice on how to stay safe from fire, including:

- how to prevent fire happening
- what to do in the event of a fire
- cooking and electrical safety
- planning an escape route
- and a night time routine

If we find the adult needs smoke alarms fitting in the home or that existing faulty alarms need replacing, we will do this free of charge during our visit. There may also be other help we can offer specific to the circumstances, such as additional fire safety equipment or referring the adult (with consent) to an organisation or agency that may be able to offer further support.

Fire Safety: Practitioner Training Sessions

Avon Fire & Rescue Service (AF&RS) aim to prevent further fatalities by working with local agencies and practitioners who engage with vulnerable members of the community.

This free training which will take around 1 hour 15 minutes, aims to help practitioners understand the risk and dangers of fire for those most vulnerable. It will cover topics including; cooking practices, hoarding, candles and smoking safety, electrical safety and how to make a referral into AF&RS.

Firesetter Intervention Scheme

Avon Fire & Rescue Service (AF&RS) offer free training to organisations who work with children and families to understand the risks of firesetting and the intervention scheme we offer to support children and young people who display this behaviour. Our trained Firesetter Advisors work with children and young people up to the age of 18 (or 25 if the young person has special education needs and disabilities (SEND) and/or an education, health and care (EHC) plan is in place) to increase awareness of the dangers and consequences of fire and establish a cause behind the actions.

Strangulation Prevention Training

FREE Online Sessions in two parts: 1pm-4.30pm Tuesday 28th June & 1pm-4.30pm Wednesday 29th June 2022

Strangulation and suffocation are sadly widespread (estimated at 20,000 cases per year in the UK). Being strangled not only leads to potential serious medical consequences that should be identified early on, it also raises by seven-fold the risk of becoming a future domestic homicide victim. It is also widely experienced in rape. A 2021 study from Saint Mary's SARC Manchester showed that 1 in 5 adults presenting for a forensic medical examination following a report of rape by a partner or ex-partner gave a history of strangulation as part of that assault.

A new specific offence of non-fatal strangulation and suffocation will come into force in England and Wales in June 22 so this training will help staff prepare for managing these assaults.

Training is suitable for NHS frontline including Paramedics, GP Practices ENT, ED; Police; Domestic Abuse and Sexual Assault Services; Judges and Magistrates, Prosecutors; Social Workers; Public Health; Probation.

It is relevant for all front-line NHS staff as we know from the USA that it is often for example GP practice nurses or A&E staff who pick up that someone has been strangled when they present with eye, throat, ear or other problems. This is particularly true for those victims who are wary of reporting to the criminal justice system.

Listening to Young People - Understanding Confidentiality



The most recent Pupil Survey found that 58% of young people didn't feel comfortable seeking mental health support as they didn't want their parents to know.

The Youth Board have considered this and have asked that practitioners give more information to young people about the rules of confidentiality. What will be shared? What never will?

The Youth Board hope this will enable young people to make an informed decision about whether they seek out support.

National – What's New?

Child Protection In England: The National Review following the Deaths of Arthur Labinjo Hughes and Star Hobson.

On 26th May 2022, the National Panel published its latest national review, which looked at the tragically short lives of Arthur Labinjo-Hughes and Star Hobson.

The review was the first of its kind and aimed to understand what happened to Arthur and Star. It considered how agencies acted to safeguard both children, and what factors enabled or limited their ability to protect them, in order to identify improvements for the future.
